

# FAMILIAR KIDS TERMS OF USE & CONSENT FORM (CHILDCARE + OPTIONS)

To ensure safe and reliable childcare services, please read and agree to the terms below before submitting your application.

## 1) Eligibility

- Children aged 18 months through 2nd grade ( 8years old ) are eligible.
- For safety reasons, we may decline care if your child has a fever of 37.5°C (99.5°F) or higher, vomiting, or diarrhea on the day of use. (this facility is not a sick-child daycare. )

## 2) Reservations / Hours

- Hours: Weekdays / Weekends / Holidays 8:00 AM-8:00 PM (Last check-in 7:30 PM)
- Closed on facility closure days (Perie Chiba Main Building / Tekko Building).
- Reservations are required. Please book via our website or by phone. Same-day reservations may be available depending on capacity.

## 3) Fees / Payment / Cancellations

- Fees: <5 hrs billed in 30-minute increments (rounded up); 5-12 hrs billed at flat-rate packages(See the fee schedule.)
- Payment is due at pick-up.
- To cancel, please notify us in advance by phone or LINE (no standard cancellation fee).
- No contact within 30 minutes of the scheduled start time: reservation will be canceled and 100% of the day's fee will be charged.

## 4) Drop-Off / Pick-Up

- If your pick-up time changes, please contact us as soon as possible.
- Even if the time changes on the day of use or pick-up is earlier than planned, fees are calculated based on the reserved time.
- The facility closes at 8:00 PM and we do not offer extensions. If pick-up occurs after 8:00 PM due to unavoidable circumstances, an after-hours service fee (as separately specified) will apply.

## 5) What to Bring (Hands-Free Options Available)

- Please bring items as needed (e.g., drinks, snacks/meals, a change of clothes, underwear, diapers, wipes, plastic bags).
- Please label all belongings with your child's name; unlabeled items may not be eligible for compensation.
- Chiba: No refrigerator or microwave. Staff do not prepare formula.
- If items run out, we may provide them through a paid Hands-Free Plan or à la carte options (see the fee schedule).

## 6) Options (Hands-Free / Meals, etc.)

[Plans] Hands-Free Plan / Hands-Free Plus / À la carte options (see the fee schedule)

### [Meals & Snacks]

- Eligible children are those who have completed the transition to toddler meals.
- For children with food allergies or never-tried (first-time) foods, please bring meals/snacks from home for safety.
- Meal service times: Lunch 11:00 AM-12:00 PM / Dinner around 4:30 PM-5:00 PM (Yaesu: until around 6:00 PM).
- Service outside these time windows and taking leftovers home are not available due to food safety and hygiene controls.
- Menus are announced monthly via our website and LINE.
- Reservations are required and must be completed by 5:00 PM the day before, together with the childcare reservation (same-day ordering is not available).
- Cancellations must be made by 5:00 PM the day before. After that time, the meal fee will be charged.

[Diapers] Please inform staff of your child's diaper size.

[Change of Clothes] A deposit (JPY 1,000 per item) applies. Deposits are refunded with on-time returns (underwear is non-returnable: JPY 500; late returns are non-refundable).

\*Option fees are paid together with childcare fees (some items, such as clothing deposits, may be handled separately as notified).

## 7) Emergency Response

- In case of injury, fever, or other urgent symptoms, we will contact the emergency number provided by the guardian.
- If necessary, we may coordinate care with our adjacent medical clinic and/or emergency services and relevant authorities. Please cooperate by arranging pick-up as soon as possible.

## 8) Information Sharing

- To ensure safe childcare, guardians are asked to share relevant information, including: allergies, underlying conditions, current medications, behavioral concerns, or developmental considerations requiring support.
- Depending on the situation, we may consult with you regarding appropriate use and safety measures.



## 9) Personal Information

- Personal information provided on the application form will be managed appropriately in accordance with applicable privacy laws.

## 10) Other

- Services may be suspended due to natural disasters, severe weather, or disruption of transportation.
- If facility property/equipment is damaged, we may consult with you depending on the circumstances.
- If an incident occurs due to the negligence of the company or staff, we will respond within the scope prescribed.
